## 2. Legal Framework

When Thailand adopted a legal marital system in 1941, the recognition of a same-sex spouse was beyond the imagination of the legislature at that period. All along, the different marital-related laws, from marrying divorce, apply to a heterosexual couple. Each statute has different grounds for affecting the marital status which give rise to the division of assets and alimony after a divorce. What needs to be pointed out here is that the law in Thailand and each type of family regime protects only the rights and obligations of a heterosexually married couple. ## 2.1. Marriage Laws in Thailand

Thai law does not define the family strictly by marriage. There is no coercion from a couple to register their marriage to be defined as a family by Thai law. Unions that do not involve marriage licenses possess essential components of marriage, such as the couples notifying other people that they are emotionally and legally bound to each other. A couple marrying with the government office is getting subjected and favored with various rules and provisions, which is different from those not registering with it. Couples marrying in a government office are sometimes called 'formal' or 'court' married. Those people who must follow the state marriage regulations always find them more cumbersome as compared to those who can keep their own agreement. Whereas in Thailand, all Khet interests are licensing, and they license all comers, subject to laws against polygamy, and rules against close blood relationships. It is much easier to marry in Thailand in a government office than to marry outside it and claim personal autonomy. Formal marriages are not a steady income for Khet. Understanding this, Khet could grant SSM through licenses in Thailand. No couple needs a Khet license for personal arrangements or to pledge themselves to emotional and financial unions. In nearly every situation where a couple needs a visa, a hospital partner visitor pass, a work-based insurance policy, health benefits, or some other reason, they would need a government marriage license. Thus, for practically all Thais and foreigners who desire a legally valid marriage, they avoid nearly all complications by getting their marriages performed in government offices. Informal marriage partners are liable to face state marriage laws and are subject to government civil codes that impede the survival of grieving partners and other aimed benefits. Whereas Thai law requires evidence of a marriage license, only insofar as health officials and other government officers interpret the various laws and regulations; an important result for a couple of having a marriage license in Thailand is to make it easy informally to hold important family or personal property interests, whether recognized by Thai or other governments. In the 1930s during the reign of King Rama VII, permission through a license from the Adviser's Office was needed so one man or woman could marry. In 1930, after the beginning of marriage license regulations, the fee was 2.5 Thai Baht. Homosexuality was illegal until 1956. Thai government offices recognize many important alternative marriage and family signals. Based on a formal Khet file in Thailand, a foreign partner may seek a marriage visa. The foreign partner must leave Thailand, his residence away from Thailand provided with documents. A formal Khet recognizes any marriage that does or does not follow the regulations. Whenever they desire informal couples may formally settle their marriage agreement. A government court ceremony is optional. A non-formal second ceremony is usual mainly for the non-Thai families and the friends residing locally. Briefly neutrally scripted Thai-language verbal contracts are only available from government offices without a dress code. In 2001, the Thai Supreme Court assistant recognized the informal marriage of an Australian-Thai couple through their pre.

# 2.2. Recognition of Same-Sex Marriages

The discussion of same-sex marriage in Thailand focuses basically on their legal status, and it is still not agreed upon whether such marriages can be recognized. All of that just evolved not so long ago. While the same-sex couples have gotten married in some temples or organizational processes, legally, according to Thai law, the answer is unfortunately no. They are registered as life partners, allowing less than half of the marriage rights critically required in their married life. This is a concern, for instance, in taking care of their legality regarding children or other rights required by both couples. The move taken by the Attorney General draws from the broader social discussion of same-sex marriages. Speaking broadly, same-sex couples cannot register as married couples in Thailand, although many are in favor of a change in the law for marriage equality rights over the past decade, especially recently. Most of them include several political parties and some academics. An equal marriage petition was sent several times to a Thai agency in charge of the subject and received international media attention. So far, the advocates have conducted public hearings and seminars on marriage equality rights. An open letter about the detailed guidelines has been published, along with addressing the media reports primarily. "The marriage laws and the recognition debate may change, since this is an

unfinished issue," says the Center. In the revised regulations, many changes to similar laws and regulations are still being reconsidered, especially in Europe and America. Consequently, it is definite that some couples would like to refer to the marriage law under the domestic foreign registration guidelines for couples married in those jurisdictions to use their marriage law in signing in Thailand according to Article 91 Section 2 of Civil and Commercial Acts on international private law that are seldom cited.

Overall, advertising will establish Thailand as a perfect wedding destination and a land of love and experiences that LGBTQ couples can share with the world. The visibility of Thailand as friendly to the LGBTQ visitors is one way of promoting press coverage and improving rankings. This expense can be supported by the relevant authorities for free.

# 5.1. Collaborations with LGBTQ Influencers

Influencer Collaboration Vendors from various countries shared their experiences in working with LGBTQ Influencers and Influencers who, though not of the LGBTQ couples, most actively support and amplify LGBTQ content. Generally, it will benefit Thailand if it appeals to a bigger audience to showcase all walks of life, as it crosses cultural and diversity barriers and also breaks the stereotype held by several Asians with regard to entertainment.
